#### Job Description: For the executing the electrical load audit & thermography of HAHC Hospital Block-A, B & HIMSR as per the direction of Health & Family Welfare & National Disaster Management Authority guidelines.

#### **ELIGIBILITY CRITIERIA**

- A. Bidders must have Registered contractor at Govt./ Semi Govt. /State Govt./Departments/Educational institutes or Working/worked Agencies at HIMSR worked with Semi/State Govt. departments/Higher Educational Institution. Bidders have to submit the related copies of the documents and other registration certificates, Work orders and completion certificates. The original will have to be produced when asked for verification.
- B. The Bidders must have current PAN, GST Registration Certificates

- 10. The details of a summary report submitted by the audit agency may be shared with the Department of Health & Family Welfare, National Disaster Management & Delhi Fire Service if required.
- 11. If any observation is coming from the Government authorities i.e. the Department of Health & Family Welfare, National Disaster Management & Delhi Fire Service it will be resolved immediately and the sole responsibility contractor/ agency.
- 12. The electrical load audit & thermography should be done as per the proper coordination with the concerned engineer in charge & all safety norms should be strictly followed.
- 13. Details of similar works executed in Higher Educational Institutions, hospitals, or Working agencies at HIMSR. Please attached the minimum one compilations certificate of 80% of the work value during the last two financial years.
