REPORTING PROCEDURE

The candidates who have been allotted a seat in PG (MD/MS) through MCC PG MD/MS online Counseling-2024, are directed to complete the physical reporting with original documents, at Hamdard Institute of Medical Sciences and Research, Jamia Hamdard, Guru Ravidas Marg, Hamdard Nagar New Delhi-62, as per MCC reporting schedule announced.

It is also brought to the student's notice that the official website of Hamdard Institute of Medical Sciences and Research is www.himsr.co.in and are advised to remit fee only to the account mentioned in this website. There are no other sites or accounts beyond this website. Please ensure that you are on the right website before you progress further.

The step-by-step reporting, fee payment & admission process for PG MD/MS course are given below. It is instructed that all the allotted candidates should adhere to the process strictly.

STEPS TO BE FOLLOWED

STEP – 1 Fee payment through DEMAND DRAFT/RTGS/NEFT/WIRE/ SWIFT Transfer

General & Reserved Category:

Candidates who have been allotted a seat in MCC counseling (Round-1/2/3 Stray Round) for PG MD/MS seats, are directed to make the Tuition fee payment, as per fee structure given on <https://www.himsr.co.in/md-ms-admissions-2024-25/> through online transfer (RTGS/NEFT) or Demand Draft to the HIMSAR account, **Fee should be submitted in single transaction if submitted by RTGS/NEFT or Single Demand Draft only** and proof of Remittance/Acknowledgment has to be scanned and e-mailed to finance.accounts@himsr.co.in, & admission@himsr.co.in.

Foreign/NRI/NRI Sponsor Category:

For Foreign/OCI/PIO/NRI/NRI sponsored candidates, the prescribed **tuition fee must be paid in US Dollars (\$) only** as per fee structure given on <https://www.himsr.co.in/md-ms-admissions-2024-25/> through **WIRE/SWIFT Transfer from the Sponsor account, Fee should be paid in single transaction** and for the same, **candidate must produce proof of the transaction made from the sponsor account compulsorily** and proof of remittance/acknowledgment has to be scanned and e-mailed to finance.accounts@himsr.co.in, & admission@himsr.co.in

STEP – 2 Scanning & E-mailing of all Original Documents (As per list)

All the candidates, who have been allotted the seats are directed to scan the individual original documents as listed at <https://www.himsr.co.in/md-ms-admissions-2024-25/> and keep them ready for e-mailing on admission@himsr.co.in before physical reporting in the institute.

Please note the Scanning of the documents is to be done from original documents only

All documents should be scanned individually for e-mailing.

The Photocopy (Xerox) of the documents e-mailed are not accepted.

Additional Original Documents required for NRI/NRI Sponsored student's need to be e-mailed as per the list provided on www.himsr.co.in (For NRI/ NRI Sponsored/Foreign National)

All Original Documents which have been scanned and e-mailed shall have to be produced for verification during the time of Physical reporting.

STEP – 3 Physical Reporting, as per MCC reporting schedule

After the successful submission of fee and e-mailing documents, **the candidate must report physically** to the Hamdard Institute of Medical Sciences and Research, Jamia Hamdard, Guru Ravidas Marg, Hamdard Nagar, New Delhi-62, as per MCC reporting schedule announced, compulsorily.

After the successful submission of fee and physical reporting with original documents in HIMSR as per MCC reporting schedule announced, **the original documents** will be verified by the designated Documents Verification Officer.

Once verification is completed and the institution is satisfied with the documents produced and payment of fee made, further reporting formalities will be completed at MCC web portal by HIMSR Nodal Officer.

STEP – 4 Verification & Submission of original documents

During Physical reporting with original documents, as per MCC reporting schedule announced, the candidates must submit all original documents listed at <https://www.himsr.co.in/md-ms-admissions-2024-25/> and same will be verified by the designated Nodal officer

Once verification and submission of original documents is completed and if the institution is satisfied with the documents produced and payment of fee made, further reporting formalities will be completed.

Discrepancy if any found, the HIMSR will not process their admission & reporting formalities at MCC portal as well at HIMSR office

STEP – 5 Reporting of admission at MCC web portal by the HIMSR & Generation of Admission Letter

On successful completion of all steps / process defined above, the admission/reporting details of the candidate will be uploaded to MCC web portal by HIMSR Nodal Officer and allotment letter will be generated and admission & reporting formality will be completed.

After generation of admission letter it will be signed by head of institution, the students are required to take the provisional letter of allotment before leaving the campus.
